### **New Braintree Dog Control By-Law, Chapter XI, SECTION 1 - LICENSING**

All dogs over six months of age in the Town of New Braintree shall be licensed with the Town Clerk no later than June 1<sup>st</sup> of each year. To be eligible for a license, the owner must provide proof of rabies vaccination. To be eligible for the neutered male license fee as set forth in Section 6, the owner must provide proof that the dog has been spayed or neutered. Initial license for kennels of more than ten (10) dogs must have a hearing before the Board of Selectmen. Failure to license a dog by July 1<sup>st</sup> subjects the owner to a \$10 late licensing fee. This late license fee shall include one fee for licenses delinquent as of July 1<sup>st</sup> and an additional fee of \$25 will be assessed if your dog is not licensed by September 1<sup>st</sup>.

***PLEASE BE AWARE THAT THE OWNER OF ANY UNLICENSED AND/OR UNVACCINATED DOG WILL BE SUBJECT TO BEING SERVED WITH A NON-CRIMINAL CITATION AND THE FEES ASSOCIATED WITH THE CITATION, UP TO AND INCLUDING COURT FEES ASSESSED. (MA General Law, Chapter 140, Section 137 and Section 141)***
