INVITATION TO BID**

The Town of New Braintree Selectboard requested sealed bids on the following materials to be used for Fiscal 2027, which ends on June 30, 2027:

- Unleaded Plus (89 Octane) Gasoline
- Low Sulfur Diesel Fuel- Winter Blend from 11/01/2026 - 03/01/2027
- No. 2 Fuel for Highway Barn, Town Hall and Fire Station
- Propane for Highway Barn
- Heating Equipment Service for FY27

The Highway Facility has a 1,500-gallon diesel tank, 500-gallon gas tank and six 150 gallon propane tanks. The Town Hall has two 319 (minimum) oil tanks 120 gallon propane tank.

The Select board reserves the right to waive any informality, to reject any or all bids and to make awards in a manner deemed in the best interest of the Town.

These items are based on projected work and seasonal requirements. The Town reserves the right to increase or decrease the quantities required.

Fluctuating prices are acceptable for bidding. Figures shall be based on The Journal of Commerce Oil Price Daily and include any additional mark-ups, charges or fees. Wage rates shall be in accordance with Labor and Industries of Massachusetts General Laws Chapter 149, Section 26-27G, inclusive.

Sealed bids to be marked "Fuel Bid".

All bids shall be accompanied by a bid bond of five percent (5%) of the value of the bid. Bids will be accepted until 12:00 PM- Noon on Thursday June 11, 2026, in the Select Board's Room, Town Hall, New Braintree, MA. The bids will be publically opened and read at 12:00 PM that afternoon.
